 - Conditions for approval are as follows:
 - The fire escape should be painted black
 - The applicant should reconsider the font-style on the marquee
 - Recommendation to conditionally approve a Certificate of Appropriateness application submitted to the Landmarks Preservation Commission for installation of hinged patio doors on the existing fourth floor at **240 St. Johns Place** (between 7th/8th Avenues), Park Slope Historic District. (*minutes 1/25/2018*)
 - Conditions for approval are as follows:

- Patio door openings should be lowered or reconfigured so as to be aligned with the window head and to be less visible from the street
- Window head trim should be eliminated in an effort to maintain the height of the door opening while also aligning the window with the doors
- Recommendation to disapprove a Certificate of Appropriateness application submitted to the Landmarks Preservation Commission for a vertical enlargement of an existing skylight bulkhead and new rear roof deck and fencing along the roof perimeter at **638 10th Street** (between 8th Avenue/Prospect Park West), Park Slope Historic District. (*minutes 01/25/2018*)
