The meeting was called to order and a motion was made by Tom Miskel and seconded by Lou Sones to approve the minutes of the previous meeting held October 24, 2011.

Continued review and discussion of an unenclosed sidewalk café permit application renewal submitted to the Department of Consumer Affairs on behalf of Cee Restaurant LLC dba Savoia at 277 Smith Street (between Sackett/Degraw Streets), to permit 8 tables and 16 seats.

The item was tabled because owner or representative were not present.

Presentation and review of an enclosed sidewalk café permit application renewal submitted to the Department of Consumer Affairs on behalf of Marco Polo Take Out LLC at 347 Court Street (between Union/President Streets), to permit 4 tables and 8 seats.

This item was tabled because owner or representative were not present.

Presentation and review of a cabaret license application submitted to the Department of Consumer Affairs on behalf of Chooks LLC dba Serengeti Restaurant at 287 9th Street (between 4th/5th Avenues).

This request for a liquor and cabaret license was tabled until applicant completed questionnaire.

Continued review and discussion of an on-premises liquor license application submitted to the State Liquor Authority on behalf of Los Robles Corp. dba Colombia in Park Slope at 376 5th Avenue (between 5th/6th Streets).

This request is for a new liquor license. The business has been operating as a restaurant for 9 months. A motion was made to approve the request subject to their getting a certificate of occupancy or a letter of no objection. The motion was made by Joe Porcelli and seconded by Tom Miskel.
